- First Games: September 19, 2021 - March 20, 2022
- No games: Deer Hunting Nov.14, Christmas Dec.26, New Years Jan.2, Super Bowl Feb.13)
- 50 minute game times, one resurface at the end, 10/10/12 stop time periods

- Team League Fee total \$4,350/team (\$200 deposit to secure spot).
- Team League Fee includes referees and scorekeeper for all games.
- Payment plan option: \$3,000 by 9/12/21 and \$1,350 by 12/1/21
- Beer/Drink Additional Option: \$600/team for \$25/24 drinks x 24 weeks
- Decided at the Wednesday, August 11, 2021 7:30pm league meeting:
 - 1) Evaluate 18B and 18C divisions after 4 games, then finalize divisions and playoff schedule. 2) Playoffs: Must be rostered on the team by December 1st to be eligible to play on that team. 3) Roster: Players can only roster for one team in one division. 4) Roster: 20 maximum players 5) Subs: If 10 guys show up for game NO Subs allowed 6) Payment: If team fee is not paid by December 5th forfeit game. 7) Full Schedule on website: 4weeks of games + 1st week scrimmages will be on website, then meeting to evaluate 18B and 18C divisions and finalize division and playoff schedule. 8) Refs Reminder 18B&18C Red line (50 & 35 Blue line). 9) Odd Team amount in a Division: Bye week for the odd team, they will get that sheet of ice to skate.
- *General Information:*
 - Every team makes playoffs; teams will be seeded according to their regular season point total, with 2 points for a win and 0 points for a loss record on the basis of a) head to head competition, b) goals against, c) goals for, and if needed d) coin toss. Playoffs will be single elimination. There will be two referees per game and a scorekeeper. A schedule will be available online prior to the beginning of the season. Game times are subject to change due to scheduling conflicts. All leagues rules are subject to change based on popular demand of the teams and players associated as well as Crystal Fieldhouse management.
- *Game Format:*
 - 1) Five vs. Five. 2) Three minute warm-up. 3) 10,10,12 minute periods with stop time and one-minute intermissions. 4) If teams are tied at the end of regulation, a 3 man shootout ensues, with the visiting team shooting first. 5) No time-outs will be provided during the regular season. 6) Playoffs will allow 1 minute timeout per team; 5 minute overtime, followed by shootout (standard protocol).

 - 1) Players must be of the appropriate age specified for each league. 2) Players must be registered under USA Hockey; Visit usahockeyregistration.com 3) No pucks or skaters are allowed on-ice until Zamboni doors are closed. 4) This is a no-check league. 5) Checking from behind results in league DISQUALIFICATION. 6) USA Hockey rules apply, minor penalties are two minutes and major penalties are 5 minutes. 7) Minimum of six players must show for a game otherwise it is a forfeited game, if this number is not reached, teams may distribute available players for a scrimmage. 8) Crystal Fieldhouse management reserves the right to suspend individuals for any extraneous altercation after hearings are conducted. Any player involved in a 2nd occurrence may be suspended for the remainder of the season. No refund will be provided to those suspended for altercations, no exceptions. 9) Crystal Fieldhouse management will deal with any problems with the league in a fair manner, however all decisions are at the discretion of Crystal Fieldhouse management. 10) Crystal Fieldhouse reserves the right to move teams to the proper level if their caliber of play is inappropriate to the standard of the league entered.
