All players must initial acknowledging they have agreed to the rules and conditions of Crystal Fieldhouse Adult Hockey League Information. Furthermore, all team representatives will be contacted to fill out any additional team information.

Crystal Fieldhouse Adult Hockey League Information

General Information:

Every team makes playoffs; teams will be seeded according to their regular season point total, with 2 points for a win and 0 points for a loss record on the basis of a) head to head competition, b) goals against, c) goals for, and if needed d) coin toss. Playoffs will be single elimination. There will be two referees per game and a scorekeeper. A schedule will be available online prior to the beginning of the season. Game times are subject to change due to scheduling conflicts. All leagues rules are subject to change based on popular demand of the teams and players associated as well as Crystal Fieldhouse management.

Game Format

1) Five vs. Five. 2) Three minute warm-up. 3) 13,13,14 minute periods with stop time and one-minute intermissions. 4) If teams are tied at end of regulation, a 3 man shootout ensues, with visiting team shooting first. 5) No time-outs will be provided during the regular season. 6) Playoffs will allow 1 minute timeout per team; 5 minute overtime, followed by shootout (standard protocol).

Rules:

1) Players must be of the appropriate age specified for each league. 2) Players must be registered under USA Hockey; a copy must be mailed to Crystal Fieldhouse or emailed to info@crystalfh.com. Visit usahockeyregistration.com for information. 3) Players must compete in at least 6 regular season games to be eligible to compete in playoffs. 4) No pucks or skaters are allowed on-ice until Zamboni doors are closed. 5) This is a no-check league. 6) Checking from behind results in league DISQUALIFICATION. 7) USA Hockey rules apply, minor penalties are two minutes and major penalties are 5 minutes. 8) Minimum of six players must show for a game otherwise it is a forfeited game, if this number is not reached, teams may distribute available players for a scrimmage. 9) Maximum of 20 players can be registered on any one team. 10) Crystal Fieldhouse management reserves right to suspend individuals for any extraneous altercation after hearings are conducted. Any player involved in a 2nd occurrence may be suspended for the remainder of the season. No refund will be provided to those suspended for altercations, no exceptions. 11) Crystal Fieldhouse management will deal with any problems with the league in a fair manner, however all decisions are at the discretion of Crystal Fieldhouse management. 12) Crystal Fieldhouse reserves the right to move teams to the proper level if their caliber of play is inappropriate to the standard of the league entered.

Defensive zone blue line icing (no red line). No slap shots (above waist height).
