- 1) Three vs Three 2) Two(2) 7.5 minute periods with running time 3) Teams will be seeded according to their point total, with 2 points for a win, 1 point for a tie, and 0 points for a loss record on basis of a)head to head competition. 3) If teams are tied at the end of regulation, each team receives 1 point 4) There will be (1) one scorekeeper/mediator per game.

### Rules:
